

1. INTRODUCTION:

- 1.1 Kum 1972 a Union Territory-a Mizoram hlan kai a nih atang khan Mizoram sawrkar hnuaiah faina lama hmalakna ngaihpawimawh a ni chho nghal a. Tichuan, kum 1977, 2nd October khan Mahatma Gandhi piancham denchhenin Local Administration Department hnuaia 'Sanitation Wing' hmalaknain 'Faina Hapta' (Cleanliness Week)chu hman tan a ni chho ta a. LAD hian he programme hi kum tin a kalpui chho ta zel a. 7th August, 2006 a Urban Development & Poverty Alleviation Department a lo pian khan 'Sanitation Wing' chu LAD atangin UD&PA Department-ah transfer a ni ta a. Chuta tang chuan Cleanliness Week chu UD&PA Department hmalakna hnuaiah a awm zui ta a ni. Tun thleng hian he Cleanliness Week hi UD&PA kaihhruaina a hman a ni ta zel a ni. AMC a lo din tak hnuah hian Aizawl khawpui bikah chuan Cleaniness Week hi Aizawl Municipal Corporation in a kengkawh tura ngaih a ni a. District Hqtrs. leh khawpui lian zual deuhah chuan UD&PA Department leh a kaihhnawih Officer te hmalakna hnuaia neih tura ruahman thin a ni.
- 1.2 Mizoram Khawpuite hi a tlangpuiin a fai viau a. Amaherawhchu hmasawnna tur kawng tam tak a la awm zel a. India Sorkar in Swachh Bharat Mission a kalpui hnuah hian India ram pum angin faina ngaihpawimawhna a lo sang lehzual a. Kum 2019, kan Hnam Pa Mahatma Gandhi kum 125 na kumah hian India ram khaw tinte chu khaw fai tak kan lo nih theihna turin chak takin kalpui mek a ni a.
- 1.3 Mizoram Sorkar pawhin Faina kawnga chak lehzuala hmalak tumin "The Mizoram Urban Sanitation & Solid Waste Management Policy-2011" chu neiin kawng hrang hrangin hma a la chho mek a. He Policy hnuaiah hian Mizoram State Sanitation Task Force chu din niin he Task Force hian State pumpuia faina kawnga hmalakna a khaikhawm a. Tin, NEDP hnuaia Climate Change Mitigation atangin hmalakna tur sum ruahmanna a lo awm bawk a. Hemi atang hian hmalakna kal chhohpui mek a ni.
- 1.4 He Faina kawnga hmalakna a lo chak lehzualna turin Task Force chuan Mizoram Khawpui te hi Faina kawngah Inelna nei se tiin ruahmanna a siam a. He ruahmanna ang hian UD&PA Department chuan kumin 2017 ah khan a vawikhatna turin Clealiness Competition hlawhtling tak a a kalpui tawh a ni a, kumin 2018 hian a vawihnihna turin intihsiak neih a lo ni leh dawn ta a ni.

2. FAINA COMPETITION:

- 2.2 He khawpui Fai Inelna Mizoram-a kan neih hi, Ranking mumal tak a siam a ni a. Kum khat lo liam leh hnua inelna neih leh hma chu he Faina Ranking hi a ding reng dawn a, khawpui fai ranking a ni reng dawn a ni. Kum tin he inelna neih thin tur a ruahman hi, a kum leh a India ram pumpui khawfai inelna Swachh Survekshan neih thin a atana Mizoram khawpuite in ruahmana tha tak a nih pawh beisei a ni a, chu mai bakah, Mizoram mipuite a bikin khawpui a chengte faina lama hma kan sawn zelna atan leh kan lo changkan zel theihna tana rah tha a chhuah ngei Mizoram Sorkar chuan a beisei a ni.
- 2.3 Tichuan, Faina kawnga kan khawpuiten hma a lo sawn zelna turin Mizoram State Sanitation Task Force (MSTF) chuan 2018 Faina Hapta hman rual hian khawpui fai inelna "Cleanliness Competition in Mizoram (Urban)" chu neih turin a lo ruahman leh ta a. He inelna ah hian Mizoram-a khawpui 23 te an tel vek ang a. Mizoram khawpui te hi Category 2-ah thenin hetiang hian inelna siam a ni ang:

Khawpui hrang hrang 23 te hi an len dan a zirin thenhran an ni a, Category I leh II ah thenhran niin, hetiang hi kum 2017 khawpui fai inelna a lawmman dawngtute chu an ni.
