**AIZAWL MUNICIPAL COUNCIL  
(CONTROL OF PARKING AND COLLECTION OF PARKING FEES)  
REGULATIONS, 2012**

In exercise of the powers conferred by Section 371 read with clause (vi) of Section 57 of the Mizoram Municipalities Act, 2007 (Act No.6 of 2007), the Aizawl Municipal Council do hereby make the following Regulations, namely :—

**1. Short title, extent and commencement.-**

- (1) These Regulations may be called the Aizawl Municipal Council (Control of Parking and Collection of Parking Fees) Regulations, 2012.
- (2) They shall apply to the whole of Aizawl Municipal Council Area.
- (3) They shall come into force on the date of their publication in the Official Gazette.

**2. Definitions.-**

- (a) "Act" means the Mizoram Municipalities Act 2007 (Act No.6 of 2007);
- (b) "Chairman" means the Chairman of the Aizawl Municipal Council;
- (c) "City" means the city of Aizawl;
- (d) "Place of parking" means the places as notified by the AMC demarcating and specifying within the city on any portion of roads, footpath and open spaces etc for the purpose of parking of vehicles;
- (e) "Officer" means any officers authorized to carry out realization of fees by the Chairman;
- (f) "Vehicle" means any mechanically propelled vehicle adapted for used upon roads whether the power of propulsion is transmitted there to from external or internal sources and includes bicycle and rickshaws;
- (g) All other words and expressions used in these regulations and not defined but defined in the Act, shall have the same meaning as respectively assigned to them in the Act.

**3. Prohibition of Parking**

No owner or driver in charge of a vehicle shall be allowed to park his vehicle on any public street, thoroughfare or any open space within the limit of municipal area other than the place of parking specified for the purpose.

**4. Specification of Place of Parking**

The Chairman shall, with the previous approval of the Board of Councillors, specify such places or parking of different kinds of Vehicles by notification in the Official Gazette or local newspaper.

**5. Power of Tender by Chairman**

The Chairman, with the previous sanction of the Board of Councillors shall have the power to issue Tender on Collection of Parking Fees for one year.

**6. Power of Chairman to charge parking fees**

The Chairman may charge a parking fee on any vehicle for parking on such places specified by him as place of parking as per the rate specified in the Schedule I.

**7. Enhancement or reduction of parking fees**

The Chairman may, with the previous sanction of the Board of Councillors, reduce or enhance the rate of parking fees from time to time as specified in the Schedule I.

**8. Declaration of public street etc. for using as places of parking**

The Chairman may, with the previous sanction of the Board of Councillors, declare any part of public street, road side, footpath or any open space for using as parking place of vehicles of different kinds in consideration of need of shopping centre, public office, bus stand etc. for free movement of vehicular traffic, pedestrians etc.

**9. Parking place on Government land**

The Chairman, with the previous sanction of the Board of Councillors, and in consultation with the Department concerned, may declare any Government land for using as places of parking.

**10. Vehicles exempted from charging parking fees**

No parking fees shall be charged from the vehicle of fire brigade, ambulance, police, armed forces and civil defense organization and the vehicles of the Aizawl Municipal Council which are on duty.

**11. Prohibition of loading and unloading in any public street**

No owner of the vehicle or driver in charge of any vehicle shall park their vehicle on any roads or thoroughfare or any other public places other than the place of parking notified by the Chairman;

Provided that parking for loading and unloading may be allowed between 8:00 PM to 5:00 AM in winter and 9:00 PM to 6:00 AM in summer;

Provided further that if any owner or driver parks any vehicle on the side or on the street, road, lane, bye-lane, or public place in stead of their place or garage, after the dusk to 8:am, such owner or driver shall be liable to pay fine of Rs. 50/- (Rupees fifty) for each vehicle for each day and the same amount of fine shall have to be paid by such owner or driver for continuance of parking of such vehicle for each day;

**12. Display chart of rate of parking fees**

Aizawl Municipal Council shall display or cause to display the rates of parking fees for different kinds of vehicles and for different period of time in respect of convenient parking place.

**13. Issue of Identity Card**

Aizawl Municipal Council shall issue Identity Card to the officer or officers or agent or agents who are duly authorized to collect parking fee for each parking place wherein names and designations of the officers shall be stated clearly and officer-in-charge of the parking place is liable to produce his Identity Card as and when demanded.

All Collectors appointed under these Regulations shall be issued Identity Card which shall be invariably displayed while on duty and receipt vide Schedule – II shall be invariably be issued.

**14. Penalty**

If any vehicle of any kind whether it is two wheelers or three wheelers or four wheelers or above is found parking in a place other the places specified for parking the person parking the vehicle shall be liable to pay fine of Rs. 50/-(Rupees fifty) only for such illegal parking and in case of a continuing contravention he shall be liable with an additional fine of Rs. 20/-(Rupees twenty) only for everyday during which such contravention continues.

**15. Additional application of these regulations**

These regulations shall also extend to such public bus stand, taxi stand, auto stand, etc. as may be notified within the city.

**16. Restriction for parking at night**

No vehicle shall be allowed to park on any place or any road for more than nine hours whether it is in working hours or night without the prior approval of the Chairman

**17.** Every municipal officer lawfully delegated with the power by the Chairman to realize parking fee as per this regulations, may reasonably seek the assistance of any police officer on duty on any matter which tends to violate or is likely to cause breach of any of these regulations by any person liable to payment of parking fees and it shall be the duty of every such police officer to assist him and for all such purposes, the police officer shall have the same power which he has in exercise of his ordinary police duties.

**18.** Any fee and fine provided by these regulations shall be paid by the owner or the driver of the vehicle instantaneously. If he or she fails to pay instantaneously, he or she shall be treated as defaulter, and such default shall be dealt as per provisions of Section 374 of the Act.

**19.** The Chairman shall be co-operated by the police in carrying and enforcing the provisions of the Act and the Regulations made hereunder for maintaining good order in the matters of parking and collection of parking fees as provided in the section 363 of the Act.

**20. Repeal**

With effect from the date of commencement of these regulations, the Mizoram (Regulation and Control of Vehicles Parking) Rules, 2000 vide notification No. B. 12021/6/2010 – TRT dated Aizawl, the 10<sup>th</sup> May, 2010 issued by Transport Department shall stand repealed within the Aizawl Municipal Council Area.

Notwithstanding such repeal, any action taken or anything done or proposed to be done under the regulations so repealed shall be deemed to have been done or proposed to be done under the corresponding provisions of these Regulations.

I. A. CATEGORY A consists of

- i) Main Road of Chanmari via Zarkawt, Upper Bazar, Dawrpui and upto Raj Bhavan South Gate
- ii) Chanmari to Israel Point
- iii) Tennis Court to Khatla Kawn upto New Secretariat Complex
- iv) Mission Veng / Mission Veng Bazar Area (JL Point to Ophel Building)
- v) Tennis Court to Zodir Square via Aizawl Temple

B. CATEGORY B consists of

- i) Chanmari to Bawngkawn via Chaltlang and Ramhlun
- ii) Temple Square to Vaivakawn
- iii) Kulikawn Area
- iv) Peter's Street to New Street
- v) Treasury Square to Si kulpuikawn via Upper Republic
- vi) Bawngkawn to Sairang Road to Hrangbana Filling Station

NOTE: Vehicles using public road-ways as garage regularly or irregularly shall be given normal permission to park their vehicles on payment of above fees.

vii) Raj Bhavan South Gate to Sikulpuikawn via Tuikhuahtlang and Khatla (MG Road)

C. CATEGORY C consists of

i) All other specified parking areas within the city not mentioned in Category A and B

2. Maxi Cab & Taxi while parking at their respective stand shall pay Rs. 20/- (Rupees Twenty) per day. However, if parked in other places than their respective stands and the fees will be as per rate fixed for category wise at above.

3. City/ Town Buses in the approved demarcated stands/stops within city/town area from 5 AM to 6 PM are exempted from payment of parking fees. However, exemption shall not be given if parked at other places than their respective stands/stops and the fees will be Rs. 30/- at every three hours or part thereof.

4. Gypsy/Jeep/Car and any light vehicles belonging to Government parked at other places other than their respective officer compound/ office garage, the fees will be as per rate fixed at table above.

5. Motor Cycles/ Scooters belonging to Government servants parked in other places than their respective office compound/office garage. The fees will be as per rate fixed at table above.

6. If introduced, parking fee for Auto Rickshaw shall be Rs. 10/- per day if parked in their respective stands. However, if parked in other places than their respective stands and the fees will be as per rate fixed for LMV at the above table.

7. Tourist buses/Night buses/ Bazar buses while parking in their respective terminal shall pay Rs. 30/- per day or Rs. 800/- for a calendar month. However, if parked in other places than their respective stands and the fee will be Rs. 30/- (Rupees Thirty) at every hours or part thereof.
