**TERMS & CONDITIONS FOR ALLOTMENT OF RENTAL DWELLING UNIT UNDER  
RAJIV AWAS YOJANA (RAY) , FALKLAND, AIZAWL.**

1. Rajiv Awas Yojana (RAY) Rental Dwelling Unit (RDU) diltu chu India khua leh tui dik tak a ni tur a ni.
2. Housing Scheme/ Housing loan dang hnuaiah beneficiary a ni tur a ni lo.
3. RAY Rental Dwelling Unit a Beneficiary chu kum khata Rs.4,00,000 (Cheng nuai li) aia tam la lut lo chhungkua an ni tur a ni. Income Certificate DC Office emaw Sorkar hnathawk tan Last Pay Certificate an nei tur a ni.
4. Diltu chu kum 2022 hma lamah Aizawl ah kum 5 tal, chhungkua/inhrang chang in an awm tawh tur a ni. Sawrkar hnathawk ng het Aizawl a in leh lo neilo te chu ngaihhnathiam theih an ni ang. Residential Certificate DC Office hriatpuina an nei tur a ni.
5. RDU luah man hi thlakhat ah Rs.1,000 (cheng sang khat) a ni ang a, advance a pek tur a ni ang. Thla tin ni 10 hma in inluah man hi pek thin tur a ni ang. Hun tiam a inluah man pe lo te chuan thla tin Rs.100 (cheng za) late fee an chawi belh thin ang.
6. Luah tur a thlan te chuan an luah hma in security deposit Rs.3,000 (cheng sangthum) leh thla khat luah man Rs.1,000(cheng sang khat) , avaiin Rs.4,000/- advance in an pe tur a ni.
7. In luah man thla thum an pek loh chuan Allotment cancel a ni ang a,an security deposit forfeit an ni bawk ang.
8. In luah man hi thlatin a hun dik takah RAY Cell, Directorate, UD&PA Department Office, MINECO ah pek thin tur a ni.
9. RDU a bill (Electricity / Tui bill etc..) hrang hrang chawi ngaite a hunbi diktakah chawi thin tur a ni. A hun tak a bill pe lo te chu an chungchang ngaihtuah a ni ang.
10. House No. pek ang chiah in an luah tur a ni. Midang luah chhawn tir phal a ni lo.
11. In hi tha tak, him tak leh fel fai takin enkawl tur a ni a, thil chhia thawm that (minor repair) ngai te a awm chuan a luah in an siam tha tur a ni. In hi a chhe lai thawm that bak chu tihdanglam (pindan thiah leh adangte) theih a ni lo.
12. In luah hun chhung tur (allotment) hi kum 2 (hnih) chhung a ni ang.
13. RDU luah chu Resident's Welfare Committee (RWC) ah member an ni anga , RWC tana UD&PA Department in dan leh hrai an siam te an zawm ngei tur a ni.
14. RAY Multi Rental Housing Complex chhungah hian Sawrkar in a khap thil reng reng chu lakluh leh hman phal ani lo vek a ni. Sawrkar dan kalha che an awm chuan action laks a ni ang.
15. RDU luah midang tan a hnawksak (nuisance) an awm chuan an chung ah action laks a ni ang.
16. Inluah man hi maintenance leh tul dangah te hman theih a ni ang.
