2. Cost of Eol:

The cost of the EoI document will be ₹ 1500.00

3. Bid Security:

Eols should be accompanied by a **Bid Security** amounting to ₹ **60,000/-** in favor of Director, Urban Development & Poverty Alleviatioon Department. The Bid Security may be accepted in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any Commercial Banks or Payment online in an acceptable form, safeguarding the purchaser's interest in all respect. The Bid Security shall remain valid for a period of **forty five (45) days** beyond the final bid validity perid.

4. Time for completion of the project will be **6 (six) months** from the issue of letter of commencement of work to the successful bidder.

5. Eligibility Criteria:

To be eligible the applicant:

- The manufactures of the lift should be registered as Class 'A' with Central PWD.
- ii. Satisfactory completion of at least three similar works in last 5 years (year ending March, 2023).
- iii. Similar work shall mean works of supply, installation, testing and commissioning of lifts in **Multi storied building**.
- iv. The Supplier or Manufacturer should have **Good Financial turnover** during the last three years ending 31st March, 2023.
- v. The Supplier or Manufacturer should have qualified Technical personels & Supervisors in the field.
- vi. The Supplier or Manufacturer should not have incurred loss for more than 2 years during preceding five years ending **31st March**, **2023**.
- vii. The Supplier or Manufacturer shall be working in the field of supply, installation, testing & commissioning of lift works for the **past 3 years** consistently.
- viii. The Supplier or Manufacturer should have valid registration for Service Tax (GST) and should have **Permanent Account Number (PAN)**.

Parties fulfilling the above indicative eligibility criteria can purchase tender document from office of the Director, Directorate of UD&PA Department, MINECO, Khatla, Aizawl, Mizoram by paying **Rs. 1500/-** (*Rupees one thousand five hundred only*). (ii) Evaluation of Financial Bids:

The Bid Evaluation committee shall open the financial bids of only those bidders who have been declared technical qualified as per Evaluation of Technical Bids. The following formula will be adpted for evaluating the Financial Bids.

- (iii) The Bid Evaluation Committee shall prepare a combine score sheet of Technical Bids and Financial Bids of the qualified bidders and the weightage to be given for Technical score will be 60 and weightage to be given for Financial will be 40.
- (iv) When EoI is responded by 10 or more firms, Rules 70 Sub rule (3) (ii) of the Mizoram Public Procurement Rules, 2020 will be adopted.
