

CITIZEN'S CHARTER 2015



This Charter is a summary of what the Urban Development & Poverty Alleviation Department, Government of Mizoram offers to the public and the standards of services you can expect from it.

UD&PA – Your partner to create clean, sustainable and liveable urban areas in planned manners.

VISION

To create economically vibrant, inclusive, efficient and sustainable urban habitats within the State.

MISSION

To help promote urban areas as engines of economic growth through improvement in the quality of urban life by facilitating creation of quality urban infrastructure, with assured service levels and efficient governance. To facilitate provision of basic civil amenities, shelter, affordable housing for all, property titling and a decent quality of life to all urban dwellers, poverty reduction by convergence of different programmes and services relating to skill development, creation of livelihoods, social security and social services including health and education, address poverty in all its aspects, and to do so in a transparent, participative and citizen centric manner.

OBJECTIVES

- 1. Creating enabling policy environment for efficient and inclusive urban governance.
- 2. Facilitate creation of basic urban infrastructure relating to core municipal services to improve service levels and coverage.
- 3. Creation of urban infrastructure in Aizawl city through ADB assisted NERCCDIP.
- 4. Urban renewal using JNNURM with related Urban Sector Reforms.
- 5. Reduction in shelterlessness through Housing for All, 2022.
- 6. Reduce urban poverty by facilitating skills training and generation of employment to urban poor through NULM.
- 7. To facilitate planned development of urban and regional centers.
- 8. Improving urban sanitation and improving management of municipal solid wastes.
- 9. Capacity building of key stakeholders including elected representatives for efficient urban management.

- 1. Urban development and urban renewal and allied matters.
- 2. Urban poverty alleviation, employment for the urban poor and related matters.
- 3. Urban Infrastructure Development Scheme (UIDS) / funded under 10% Lumpsum Grants for North Eastern Region on urban development and poverty alleviation.
- 4. Slum development/ re-development.
- 5. Urban sanitation and Solid Waste Management.

- 6. Urban sewerage and septage management under JnNURM, Urban Development Schemes (UDS) under Asian Development Bank/ Mission projects of World Bank/JICA sponsored by Government of India.
- 7. Town & Country Planning administration which includes:-
 - (a) The Mizoram Regional and Development Act, 1990 and Rules there under.
 - (b) The Urban Development Plan Formulation and Implementation Guidelines, 1996.
 - (c) The National Building Code of India under the Bureau of Indian Standard Act, 1986.

- 9. Aizawl Solar City Project.
- 10. Urban Housing, Residential Tenancy, Titling and related matters.
- 11. Integrated development of small and medium towns.
